For clarity, choreographic works shall under no circumstances be reproduced by a student/s or any other third-party without the explicit written consent from a DPS Director.
- Customer data shall be collected, stored, transmitted, manipulated and processed as deemed necessary by the Directors for the purposes of research, management, monitoring and performance of both the student and the school.
- Tuition Fees are to be settled **prior to term start**. Students may not be allowed to participate in class should payment not be settled by the second week of term **at the latest**.
- Early Bird pricing on service fees may be offered from time to time. Early Bird pricing will be available for registration with settlement of fees up until the specified Early Bird deadline following which our Standard Fees become applicable. For clarity, Dance Project Studios are to receive both registration/s and full term/programme payment **ahead of the Early Bird deadline** in order for customers to take advantage of the Early Bird pricing offer.

- Dance Project Studios typically schedule a 3 week Christmas break and a 3 week Easter break with a 1 week Mid Term break each term through the scholastic year. Furthermore, we shut down over the *Santa Maria* week in summer. No standard schedule classes occur over these closure periods. We aim to align our scheduled Mid Term breaks with academic school mid terms, however, this is not always feasible dependent on the calendar year and events/ activities that are in our planning pipeline. No standard schedule classes occur on public holidays. Classes falling on public holidays are not postponed and there shall be no pro-rata refund of tuition fees for such classes.
- Service fees are due on registration for the service, i.e. ahead of the service provision, and not on invoice. Invoices for any remaining unsettled term service fees are typically issued between the second and fifth week of each term. Product fees are due on order and not on delivery of products. All invoices will be communicated to the single email address noted with each student profile on registration and they become immediately due.
- Failure to effect payments when due will constitute a default. A Late Payment Administration Fee may become applicable on overdue tuition fees. Furthermore, Dance Project Studios reserve the right to charge interest at 1% per month if fees are not settled within our terms of payment. In the event of a default, Dance Project Studios shall have the right to refer such defaults to a credit reference agency/ies for database registration.
- Services not attracting sufficient registrations may be withdrawn without notice. Should a service attract less than four (4) students, Dance Project Studios reserves the right to treat the service as a private lesson in terms of service fees and therefore private lesson rates will become chargeable accordingly. Customers will be consulted on such decisions.
- Schedules are subject to minor changes in order to optimise service delivery.
- Student absences for any reason whatsoever are not credited on account or replaceable except in exceptional circumstances and at the sole discretion of the Directors. For clarification, student absences resulting from quarantine directives and/or isolation for any reason whatsoever are not credited on account or replaceable. In the event of mandatory quarantine or isolation of a student, Dance Project Studios will endeavour to facilitate virtual participation of affected student for the classes in which they are enrolled for the effective period.
- Dance Project Studios reserve the right to substitute a class teacher as may become necessary. We will endeavour to replace any classes cancelled due to teacher unavailability.
- Class placement is entirely at the Artistic Director's discretion.

- Dance Project Studios shall **not** be held liable or in breach of any service agreement if there is any total or partial failure of performance to deliver services as occasioned by death or grievous physical injury resulting in an incapacity to perform, any act of God, fire, act of government or state, war, civil commotion, insurrection, embargo, prevention from or hindrance in obtaining any raw materials, energy or other supplies, labour disputes of whatever nature and any other reason beyond the control of the studio Directors. If Dance Project Studios is unable to perform its duties and obligations as a direct result of the effect of one of those reasons, the studio directors shall give written notice to impacted customers of the inability which sets out full details of the reason in question. Dance Project Studios' operations may be suspended during the period (and only during the period) in which the reason continues. Forthwith upon the reason ceasing to exist, Dance Project Studios will endeavour to resume service delivery as soon as reasonably possible.
- All deposits and/ or fees are non-refundable except in exceptional circumstances and at the sole discretion of the Directors. For clarification, fees relative to missed classes as a result of closure directives, quarantine directives and/or isolation are absolutely non-refundable.
- Dance Project Studios reserve the right to transition to online delivery of classes (ie virtual classes) at any point and at short notice should the need arise. No fee refunds will be considered under such circumstances.
- Students are expected to be punctual for class. It is at the teacher's discretion whether to allow a late student to enter/ participate in a class.
- Students must be promptly collected once their lessons are finished or the scheduled event/ rehearsal/ performance has concluded. Dance Project Studios will not assume responsibility for students following their lessons. More specifically, Dance Project Studios will not monitor or be responsible for who collects students from the studios and/ or other organised activities. Any exceptional circumstances are to be agreed up front in writing with Artistic Director.
- A parent or guardian to a student up to 16 years of age is to accompany the student whenever ascending/ descending the main stairs on the way into and out of the school.
- The upstairs entrance door to the studios is to be kept in a closed position at all times.
- Students must be respectful to fellow students and teachers in and out of school. Any form of rudeness and/ or bullying will **not be tolerated**.

- Due to the physical nature of classes offered at Dance Project Studios, it is understood and accepted that teachers and/ or teaching assistants may have to physically touch and handle students during lessons and rehearsal activities in order to administer correction and direct on appropriate technique.
- It is understood and accepted that some students, particularly at Nursery to Grade 1 levels, may require assistance from teachers and/ or teaching assistants whilst changing and/ or using bathroom facilities.
- Students are expected to attend a minimum of 80% of lessons in both **Autumn Term & Winter Term** to participate in the **Annual School Production**. Exceptions with a valid reason require discussion between parent and Artistic Director.
- Students are expected to attend a minimum of 80% of lessons in **Autumn Term, Winter Term & Spring Term** in order to sit for **any examinations** hosted by Dance Project Studios. Exceptions with a valid reason require discussion between parent and Artistic Director.
- Whether a student is allowed to sit for an examination or not is at Artistic Directors discretion and will be decided following consultation with the respective teacher/s.
- No chewing gum is allowed anywhere at the school.
- No eating is allowed within the studios with the exception of the designated Summer Programme lunch breaks which are supervised by Dance Project Studios' staff accordingly.
- Drinks must be in plastic bottles that can be opened and closed again.
- No jewellery or watches in class except for small studded earrings.
- Mobile phones are to be switched off or put on silent in the studios. It is at the teacher's discretion to collect mobile phones during class and to return them to student/ s at the end of class.
- Jackets, bags and shoes are to be left in the assigned or flexi hallway cubbyholes.
- Electronics and other expensive items are not recommended at school. They are the sole responsibility of the individual student.
